***“Inter Partes Review: A View From Both the Bench and the Bar”***



**BRIAN P. MURPHY** is an Administrative Patent Judge serving on the Patent Trial and Appeal Board of the United States Patent & Trademark Office in Alexandria, VA. A graduate of the University of Virginia and Fordham University School of Law, Judge Murphy is a registered patent attorney and member of the New York State Bar. Judge Murphy was a private practitioner from 1985 through September 2013, during which time he maintained an active patent litigation, due diligence, counseling, and prosecution practice, with particular expertise in Hatch-Waxman pharmaceutical patent litigation. Judge Murphy also has been an Adjunct Professor of Law at Fordham University School of Law. He now presides over AIA post grant patent trials as a member of the PTAB.
